

WAIVER AND CONSENT FORM

FOR COMMUNICABLE DISEASES INCLUDING COVID-19

ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and/or by contact with contaminated surfaces and objects, and even possibly in the air. People may be infected and show no symptoms and therefore spread the disease. The exact methods of spread and contraction are unknown, and there is no known treatment, cure, or vaccine for COVID-19. Evidence has shown that COVID-19 can cause serious and potentially life-threatening illness and even death. In accordance with applicable state and local reopening guidelines, Frozen Ropes has gained authorization to conduct camp.

For your child to participate in Frozen Ropes Camp, we ask all parents to acknowledge, appreciate, and agree that:

1. Participation in events involving close contact with others includes possible exposure to and illness from infectious diseases, including but not limited to MRSA, influenza, and COVID-19. While particular rules, use of personal protective equipment and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
2. After personally evaluating the risks and benefits of participating in Camp activities, I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the releases or others, and assume full responsibility for my child's participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for my child's participation as regards protection against infectious diseases, as well as any additional measures announced by the Camp. If, however, I observe any unusual or significant hazard during my presence or participation, I will remove my child from participation and bring such to the attention of the nearest Camp official immediately. In order to safeguard the health and well-being of other participants, I agree to abide by all recommended measures designed to limit exposure to and spread of COVID-19, including when my child is not participating in Camp activities. In the event of any suspected exposure or symptoms, I agree to notify the Camp immediately and refrain from my child attending or participating in Camp until medical professionals deem it safe to do so; and,
4. I, for myself and my child on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless the Camp and agree to indemnify its officers, instructors, directors, agents, representatives, other participants, sponsoring agencies, sponsors, and if applicable, owners and lessors of premises used to conduct the Camp ("RELEASES"), with respect to any and all illness, disability, death or loss or damage to person or property, Whether arising from the negligence of releases or otherwise, to the fullest extent permitted by law. The releasor further agrees to indemnify and hold harmless the Camp, its officers, instructors, directors, agents, representatives, other participants, sponsoring agencies, sponsors, and if applicable, owners and lessors of premises, and for any claim of any family member, other participant, or any other person that claims to be infected by releasor or as a result of releasor's participation in the Camp; and,
5. The undersigned hereby assumes responsibility for my child, and risk of illness, bodily injury, death, or property damage to the undersigned, due to negligence, active or passive, while participating in Camp activities.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS ON BEHALF OF MY CHILD PARTICIPATING IN CAMP.
